In this area of the country, dollar spot typically presents the most significant challenge on tees and fairways, but less so on greens due to the number of product applications and intervals. Fairy ring and brown patch are major concerns in spring, anthracnose is problematic in summer on *poa annua*, and *Pythium* is most difficult in the heat of summer.
